**IMPORTANT :**

- [1] New defined contributory pension scheme as introduced vide Government vernacular Resolution Dated : 18-3-2005 and 6-6-2005 No. NPN-2003-GOI-10-P will be applicable in case of candidates other than Gujarat Agricultural Universities employees and those who are recruited after 1-5-2005.
- [2] The post of SC, ST and SEBC will be filled up as per State Government rules. The reservation of posts shown above is for the *candidates of Gujarat origin and domicile only, therefore, other candidates need not apply against these posts.* SEBC candidate should furnish prescribed and current years "*Non Creamy-layer Certificate*" in the prescribed proforma along with the application form, failing which, the candidates will not be entitled to get the benefit of reserved category.

The University shall verify the antecedents or documents submitted at any time, at the time of appointment or during the tenure of the service. In case, it is found that the documents submitted are fake or the candidate has clandestine antecedents/background and has suppressed the said information, his/her service shall be terminated forthwith.

- [3] Age relaxation in case of SC, ST, SEBC and WOMEN will be applicable as per State Agricultural Universities of Gujarat (SAUGs) statutes and guidelines of Government of Gujarat from time to time.
- [4] For the candidates having Master's degree, NET shall remain compulsory along with one publication in NAAS rated refereed journal for recruitment to the post of Assistant Professor and equivalent in the disciplines in which NET is conducted should be as per the Recruitment Rules. Essentiality of NET can be waived off for the candidates holding Ph.D. degree provided it has been done with course work and research work prescribed by the UGC Regulations 2009 and the candidate has at least two full length publications having a NAAS rating not less than 4, on the last date of submission of application. Those candidates with Ph.D. degree without course work will not qualify for NET exemption.
- [5] Bachelor Degree in concerned faculty is essential.

- [6] Impact factor shall be considered as per recommendation of National Academy of Agricultural Sciences. The candidates from **Veterinary Faculty** will be exempted from NET for a period of 5 (*five*) years from the date of appointment vide Government Resolution No. 142006-3282Part-I-K-2, dated 23-01-2013 by Agril. & Co-Opp. Dept. Sachivalaya, Gandhinagar.
- [7] The period spent for acquiring M.Sc./M.Phil./Ph.D. degree will not be considered as experience except in-service period.
- [8] The candidate having Ph.D. Degree prior to 2009 if without course work shall be eligible on production of certificate from concerned University as per the UGC Regulations-2009.
- [9] Probation period shall be of two years for all the posts.
- [10] Incomplete application is liable to be rejected. Envelope containing the application should be subscribed as '**APPLICATION FOR THE POST OF \_\_\_\_\_ (DISCIPLINE : \_\_\_\_\_)**.'
- [11] The application must reach the Registrar on or before the last date prescribed for receipt of applications. The applications received after the last date shall stand rejected automatically. No intimation in this regard will be communicated to candidates.
- [12] **The Summary Form should be neatly filled in and sent with the application in ten copies compulsorily.**
- [13] Eligible candidates will be informed about date and place of interview through intimation under by post/ e-mail/ SMS. The candidates must write his e-mail ID, Mobile phone number. However, University does not take any responsibility for intimation about interview. The dates of interviews would also be displayed on the website of the University. List of eligible candidates shall be placed on the University website (<http://www.sdau.edu.in>).
- [14] All applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement. They are advised to satisfy themselves before applying that they possess, at least the essential qualifications prescribed for the post. No enquiry or advice as to the eligibility will be entertained.
- [15] Candidate must bring all the original documents at the time of interview. Non-production of original certificates will result to disqualification.
- [16] The service conditions will be governed by the University Act, Statutes, Rules and Regulations framed and amended by the University/ Government of Gujarat from time to time.
- [17] No TA and DA will be paid for appearing in the interview even if any interview is not held on scheduled date due to one or the other reasons.
- [18] The University reserves the right to decrease or withdraw the posts, change the designation and cancel the post even after interview. No claim or correspondence will be entertained in this regard.
- [19] Employee is transferable within the jurisdiction of **Sardarkrushinagar Dantiwada Agricultural University** as per University requirement.
- [20] The applications (both "advance copy" and through proper channel), may reach the **Registrar, Sardarkrushinagar Dantiwada Agricultural University, Sardarkrushinagar** either by hand or by post or by courier on or before the prescribed date. The University will in no case be responsible for non-receipt of application(s) or any delay in receipt thereof on any account whatsoever. It is also stated that no application received after the prescribed closing/last dates will be entertained under any circumstances and all the late applications will be summarily rejected, without any notice. It is therefore, emphasized that the applicant(s)/ candidate(s) should ensure that his/her/their application(s) reach Registrar Office on or before the prescribed closing/last date. For application through proper channel, the candidates are advised to submit their online application (complete in all respect) before the closing date. However, hard copy of the online application through proper channel must reach within fifteen days of the closing date. **SUCH APPLICATION RECEIVED AFTER PERIOD OF FIFTEEN DAYS SHALL NOT BE CONSIDERED.**
- [21] Instead of furnishing information in the space provided for in the application form, some candidates furnish information besides appending documents/enclosures in addition to the prescribed ones, which makes the applications unnecessarily bulky. Therefore, the candidates are advised to fill the application in the prescribed format and that too in the space provided for in the application form, and not to resort to annexure except only the photocopies of prescribed documents/certificates.
- [22] **Self attested** copies of required certificates issued by the competent authority need to be enclosed.
- [23] Photographs at the appropriate space(s) in the application form should be fixed.
- [24] Canvassing in any form will disqualify the applicant/candidate.
- [25] In case of any discrepancy, English version of the detailed advertisement appearing in websites will be treated as final.
- [26] The crucial date for determining the eligibility in respect of Age/Educational Qualifications/ Experiences will be last date of online submission of application i.e.15/5/2017.
- [27] The SEBC candidates will have to pay `1000 (^ 500 application fee + ` 500 processing fee). There will be no application fee for SC and ST candidate of Gujarat, however , they will have to pay ` 500/- as processing fee.
- [28] **The application should be submitted online from website <http://sdau.ojas.sauguj.in> after making appropriate payment (applicable as per category applying for) through State Bank of India Collect payment facility on-line only.**

- [29] The hard copy of the application along with attested copies of certificates, pertaining to the qualifications and experience accompanied with the copy of the bank payment receipt (As per "State Bank Collect" payment made via onlinesbi.com only) should reach to the **Registrar, Sardarkrushinagar Dantiwada Agricultural University, Sardarkrushinagar** on or before **Dt. 15/05/2017.**

- [30] The appointments will be made on merit basis from among the select-lists recommended by the Selection Committee and limited to sanctioned posts accorded by the Government to fill-up the number of vacant posts.
- [31] The University reserves its right not to fill-in all or any post, if deems necessary.  
Any postal delay in receipt of applications will not be considered.
- [32] Recruitment rules for the post are as per the Statute of SAUs of Gujarat.
- [33] Papers published on or before closing date of on-line submission of the application shall only be considered.

**Recruitment Rules for the post of ASSISTANT PROFESSOR and its equivalent.**

**Faculty :** *Agriculture / Veterinary Science and Animal Husbandry / Dairy Science / Horticulture / Faculty of Food Science.*

***Educational Qualifications :***

- (a) Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's degree level in a relevant subject of the concerned faculty from an Indian University.
- (b) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC/CSIR or similar test accredited by the UGC/ICAR and should have published at least one article in NAAS (National Academy of Agricultural Science, New Delhi) rated journal.  
For the candidate having Master's degree, NET shall remain compulsory along with one publication in NAAS rated refereed journal for recruitment to the post of Assistant Professor and equivalent in the disciplines in which NET is conducted by ICAR/UGC/CSIR. Essentiality of NET can be waived off for the candidates holding Ph.D. degree provided it has been done with course work and research work prescribed by the UGC Regulations 2009 and the candidate has at least two full length publications having a NAAS rating not less than 4, on the last date of submission of application. Those candidates with Ph.D. without course work will not qualify for NET exemption.

***Other Qualifications :***

- (d) The candidate should possess the basic knowledge of computer application and should have passed CCC<sup>+</sup> examination of Department of Electronic Accreditation of Computer Courses (DOEACC) society. If the candidate has not passed the CCC<sup>+</sup> examination, he will have to pass the same during the probation period, failing which his probation period will not be regularised.

***Relaxation:***

- (a) NET/SLET/SET shall not be required for such subjects for which NET/SLET/SET accredited test is not conducted.
- (b) For the purpose of eligibility and for assessing good academic record during direct recruitment, a relaxation of 5% at the Graduate and Master's level for the SC/ST/Differently-abled (Physically and visually differently-abled) categories of the candidates.
- (c) The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks excluding grace marks if any.

***Maximum Age Limit : Below 35 Years***

- (i) Age relaxable in suitable cases of the employees of the Gujarat Agricultural Universities.
- (ii) Age relaxable in case of SC, ST, SEBC and woman candidates as per the State Government Rules.

**Guidelines** for the submission of hard copy of the application to the **Registrar, Sardarkrushinagar Dantiwada Agricultural University, Sardarkrushinagar-385 506, District : Banaskantha (Gujarat State).**

- [1] Candidate needs to submit all the certificates in their serial numbers as appeared in the application form.
- [2] All the pages in the enclosures should be self attested and contain serial numbers clearly visible at a uniform position preferable in the right hand side corner for the verification. Candidate should clearly mention the total number of the pages attached in the application.
- [3] The block in the application should be filled in sequence of Surname, Candidate's name and Father's name.
- [4] Candidate belonging to the specific category needs to submit the attested copy of the “Category Certificate” duly signed by the competent authority
- [5] Educational qualification in the form should be mentioned in the order of SSC, HSC, Bachelors, Masters, Doctorate, Post Doctorate, **NET, CCC<sup>+</sup>** and any other specialisation to support the candidature.
- [6] Experience in the form should be filled starting from the recent position and the further in descending order. Accordingly, the proof indicating the length of service in each and every document must be mentioned.
- [7] Candidate should clearly mention the length of services in the different position in the separate sheet along with the form.
